Subject: Proposed U G Metro station and allied activities at Churchgate, Girgaon, Shitladevi Temple, Mahim, Mumbai by MMRCL

The proposal of U G Metro station and allied activities at Churchgate, Girgaon, Shitladevi Temple, Mahim, Mumbai was considered in 113th meetings of MCZMA held on 8th to 11th August, 2016.

2. MCZMA noted that proposal is for Under Ground Metro station and allied activities at Churchgate, Girgaon and Shitladevi Temple, Mahim Mumbai. All the three sites of stations and allied activities falls in CRZ II area as per approved CZMP and situated on landward side of the existing roads prior to 19.2.1991. Details of Proposed activities are as follows:

3. As per the decision of the Authority, the proposal is recommended from CRZ point of view under CRZ Notification, 2011 to concern planning authority subject to compliance of the following conditions:

Specific Conditions:

- i. The project activities should be carried out strictly as per the provisions of CRZ Notification, 2011 (as amended from time to time) and guidelines/ clarifications given by MoEF from time to time.
- ii. The Environment Management Plan (EMP) should be implemented in spirit and in an effective manner for protection of coastal environment.
- iii. Debris generated during the project activity should not be dumped in CRZ area. It should be disposed scientifically at a designated place.
- iv. MMRCL should restore the site after completion of the work during construction and implementation phase.
- v. All other required permissions from different statutory authorities should be obtained prior to commencement of work.

General Conditions:

- i. The MCZMA or any other competent authority, concern planning authority may stipulate any additional conditions subsequently, if deemed necessary, for environmental protection, which shall be complied with.
 - ii. The environmental safeguard measures should be implemented in letter and spirit.
 - iii. This recommendation will be valid for 5 years from the date of issue of recommendation for commencement of construction & operation.
 - iv. The recommendation from CRZ point of view is being issued without prejudice to the action initiated under EP Act or any court case pending in the court of law and it does not mean that project proponent has not violated any environmental laws in the past and whatever decision under EP Act or of the Hon'ble court will be binding on the project proponent. Hence this recommendation does not give immunity to the project proponent in the case filed against him, if any or action initiated under EP Act.
